#### **RULES**

The Contest is open to all photographers. This photo event is sponsored by FIAP, CEF and FLF, therefore it will abide by its respective rules and will count towards obtaining their honours and distinctions.

## 1.- SECTIONS

- A. Free Black and white (according to FIAP rules)
- B. Free Colour
- C. Urban Scene, (Black and white, or Colour)

#### 2.- FORMAT AND SUBMISSION

- The maximum number of works is four per section.
- The same image cannot be submitted in more than one section.
- Images must be submitted following the instructions on the website http://www.afsaxativa.org/
- Image size: Files for the projection and for the creation of a pdf. catalogue will be JPG format, 10 or 8 compression, bigger size minimum to 2400 pixels.
- Awarded images will have to be submitted in the native resolution of the camera used for taking the picture, and in .tif format.

#### 3.- REGISTRATION FEES

- The registration fee is €15 (US\$20) regardless of the number of sections in which the photographer wants to participate
- The only accepted method of payment will be PayPal, following the instructions on the website <a href="http://www.afsaxativa.org/">http://www.afsaxativa.org/</a>

## 4.- AWARDS

- Special FIAP Blue Badge prize to the author having the highest number of photographs accepted and with higher scores, in the three sections.
- FIAP Gold Medal for each section
- FIAP Silver Medal for each section
- FIAP Bronze Medal for each section

- 18 FIAP Honorable mentions (6 for each section)
- CEF Gold Medal for each section
- CEF Silver Medal for each section
- CEF Bronze Medal for each section
- 18 CEF Honorable mentions (6 for each section)
- FLF Silver Medal for each section
- 6 FLF Honorable mentions (2 for each section)

#### **NOTES**

- A. The works submitted by authors who have not paid the registration fee before the deadline (2017/11/25) will not be judged, nor will they be sent the digital catalog.
- B. By submitting a picture, the applicant certifies the work as his/her own and allows the organizers to exhibit and publish it, giving this right to Agrupacio Fotografica Setabense d'Aficionats, FLF, CEF and FIAP, who will always state the author and the title of the work. Organizers, FLF, CEF and FIAP are exempt from any liability to the claim for the rights of third parties of any kind.
- C. This contest is sponsored by FLF, CEF and FIAP and counts towards obtaining their honorary degrees, so contestants grant permission to the organizers and their upper bodies and FIAP, CEF also FLF to digitalize their personal data, always in the exclusive area of artistic dissemination of their works, and to publish their merits and prizes for obtaining FIAP, CEF and FLF distinctions.
- D. Notification of results will be made on an individual basis and will be posted on the contest's website <a href="http://www.afsaxativa.org/">http://www.afsaxativa.org/</a>
- E. E. Each participant will receive the catalog in pdf format.
- F. With the sole act of submitting his/her images or files to a salon under FIAP Patronage, the entrant accepts without exception and with no objection that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions even if the entrant is not a member of FIAP; that FIAP will use any means at its disposal for this undertaking; that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP and that in case of sanctions following the non compliance with FIAP regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations.
- G. The decision of the jury will be unappealable
- H. By submitting a picture the entrant accepts the above terms.
